Rain location: Skyline Tower Auditorium, 1247 St. Anthony Avenue, Saint Paul.

Celebrate the new Griggs bikeway and walking bridge, while also envisioning big changes for the future of the Lexington and Hamline bridges over I-94! Help our community decide which kinds of transportation infrastructure, public art, placemaking and wayfinding ideas would be best to improve north-south connections over the freeway and up to the Green Line. Better Bridges for Stronger Communities

Interstate 94 has left a legacy of separation. Saint Paul's Green Line communities report that the bridges are psychological and physical barriers to walking and bicycling. They are exposed to the elements, most are wide and motor-oriented, aesthetically unremarkable and displeasing, and in several cases, unsafe for non-motorized passage. They are also remarkable opportunities to become safe for users of all abilities, and become expressions of artistic creativity with iconic potential. Better Bridges for Stronger Communities is a community-led effort to re-envision the bridges over I-94. The project is focusing on eight bridges: Pelham, Fairview Underpass, Snelling, Hamline, Griggs, Lexington, Victoria, and Dale. The Better Bridges project aims to create both long-term community-led visions and plans for these bridges, and build short-term pop up installations on each bridge which will demonstrate improved walking, bicycling, and artistic expression at each bridge site.

The Friendly Streets Initiative

The Friendly Streets Initiative is based out of Saint Paul, Minnesota and facilitates community organizing through creative public engagement events. FSI assists communities in visioning for positive change to public spaces, collects and analyzes data, and helps neighbors navigate city planning processes. <u>www.friendlystreetsinitiative.org</u>

The Lexington-Hamline Community Council

The Lex-Ham neighborhood in St. Paul is bounded by University Avenue, Lexington Parkway, Summit and Hamline Avenues. Since the Lexington-Hamline Community Council was established in 1969, it has been the cornerstone for organizing and serving the 3,000 residents living in this neighborhood. <u>www.lexham.org</u>
